

## nwacuho 2011 experience the mosaic



# corporate business meeting voting items

In addition to an advisory vote on the FY12 budget, the following items will be considered by voting members at the annual conference at Vancouver, BC at the annual Corporate Business Meeting.

Editors Note: Italics mean suggested removal, and underlined means suggested addition.

Current Bylaw:

#### ARTICLE II. NONVOTING MEMBERS

Section 1. Nonvoting Members. NWACUHO may have NONVOTING MEMBERS, including corporate members, at the discretion of the Board of Directors.

Proposed Bylaw Change:

#### ARTICLE II. NONVOTING MEMBERS

Section 1. Nonvoting Members. NWACUHO may have NONVOTING MEMBERS, including corporate members <u>and individuals in the region from non-member institutions</u>, at the discretion of the Board of Directors.

Addition to Bylaws: ARTICLE II. NONVOTING MEMBERS

Section 3. The Board of Directors may prepare and adopt a resolution and formal written policies regarding the establishment of an individual nonvoting member. A majority of voting member institutions must approve dues and rights associated with the individual membership.

Current Bylaw:

#### ARTICLE III. VOTING MEMBERS

Section 5. Qualifications of Voting Members.

5.1 Membership in NWACUHO shall be available to either individuals who are associate members of ACUHO-I, to institutions of higher education which have housing officers involved in the coordination of administration, educational programming, food service and housing and maintenance operation for students and staff members on or off the college/university campus, and individuals in the region from non-member institutions who are affiliated with student housing and wish to actively participate in NWACUHO.

Proposed Bylaw Change:

#### ARTICLE III. VOTING MEMBERS

Section 5. Qualifications of Voting Members.

5.1 Membership in NWACUHO shall be available to either individuals who are associate members of ACUHO-I, to institutions of higher education which have housing officers involved in the coordination of administration, educational programming, food service and housing and maintenance operation for students and staff members on or off the college/university campus, and individuals in the region from non-member institutions who are affiliated with student housing and wish to actively participate in NWACUHO.

#### ARTICLE III. VOTING MEMBERS

Section 5. Qualifications of Voting Members.

5.2 Membership shall be open to qualified institutions in the states of Alaska, Hawaii, Oregon, and Washington, and the provinces of British Columbia and Alberta, Canada, and by special invitation of the Board of Directors to similarly qualified institutions in adjoining states and provinces.

Proposed Bylaw Change:

#### ARTICLE III. VOTING MEMBERS

Section 5. Qualifications of Voting Members.

5.2 Membership shall be open to qualified institutions in the states of Alaska, *Hawaii*, Oregon, and Washington, and the provinces of British Columbia and Alberta, Canada, and by special invitation of the Board of Directors to similarly qualified institutions in adjoining states and provinces.

Current Bylaw:

#### ARTICLE III. VOTING MEMBERS

Section 5. Qualifications of Voting Members

5.4 All staff and faculty from member institutions and individuals from non-member regional institutions who purchase individual membership, who have involvement in their institution's residence hall, family housing services, conference services, and programs may participate in the activities of, benefit from the services of, and hold office within NWACUHO.

Proposed Bylaw Change:

#### ARTICLE III. VOTING MEMBERS

Section 5. Qualifications of Voting Members

5.4 All staff and faculty from member institutions and individuals from non-member regional institutions who purchase individual membership, who have involvement in their institution's residence hall, family housing services, conference services, and programs may participate in the activities of, benefit from the services of, and hold office within NWACUHO.

#### **CURRENT BYLAW:**

#### ARTICLE III: VOTING MEMBERS

Section 5. Qualifications of Voting Members

5.7 Honorary membership may be awarded by the Board of Directors subject to the approval of the membership at their annual conference to past representatives who have given outstanding service to the Association.

#### PROPOSED BYLAW CHANGE:

#### ARTICLE **III**II: NONVOTING MEMBERS

Section <u>54</u>. Qualifications of <u>Non</u>Voting Members

5.7 Honorary membership may be awarded by the Board of Directors *subject to the approval of the membership at their annual conference* to past representatives who have given outstanding service to the Association. Past Presidents of the Association, unless removed from office or through resignation, are granted Honorary Membership Status.

#### **CURRENT BYLAW:**

#### ARTICLE IV. BOARD OF DIRECTORS

Section 2. Qualifications of Directors and Composition of the Board. The directors shall be the Officers, who are elected by the voting members, plus the state and provincial representatives, who are appointed by the Officers. Nominees for positions on the Board of Directors must be employed at a member institution, have demonstrated a commitment to the mission and purposes of Northwest Association of College and University Housing Officers, have the fiscal support of their host institution, and must have expertise in areas relevant to the needs of the organization.

#### PROPOSED BYLAW CHANGE:

#### ARTICLE IV. BOARD OF DIRECTORS

Section 2. Qualifications of Directors and Composition of the Board. The directors shall be the Officers, who are elected by the voting members, plus the state and provincial representatives, who are appointed by the Officers. Nominees for positions on the Board of Directors and all elected Board Members must be employed at a member institution, have demonstrated a commitment to the mission and purposes of Northwest Association of College and University Housing Officers, have the fiscal support of their host institution, and must have expertise in areas relevant to the needs of the organization.

#### **CURRENT BYLAW:**

#### ARTICLE IV. BOARD OF DIRECTORS

Section 8. Filling Vacancies. The voting members may, by a majority vote, elect new directors to fill any vacancies on the Board. A director elected to fill a vacancy will complete the term of the position they are filling.

#### PROPOSED BYLAW CHANGE:

#### ARTICLE IV. BOARD OF DIRECTORS

Section 8. Filling Vacancies. The voting members may, by a majority vote, elect new directors to fill any vacancies on the Board. <u>Vacancies in the position of State and Provincial Representative are appointed by the Board of Directors.</u> A director elected <u>or appointed</u> to fill a vacancy will complete the term of the position they are filling.

#### CURRENT BYLAW:

#### ARTICLE V. OFFICERS

Section 1. Officers. The officers of NWACUHO shall include a President, President-Elect, Past-President, Secretary, Treasurer, Products and Services Coordinator, Website Administrator and a Newsletter Editor.

#### PROPOSED BYLAW CHANGE:

#### ARTICLE V. OFFICERS

Section 1. Officers. The officers of NWACUHO shall include a President, President-Elect, Past-President, Secretary, Treasurer, Products and Services Coordinator, Website Administrator *and a* Newsletter Editor, Alaska State Representative, Alberta Provincial Representative, British Columbia Provincial Representative, Oregon State Representative and a Washington State Representative.

#### CURRENT BYLAW:

#### ARTICLE V. OFFICERS

Section 2. Election and Term of Office. The officers of NWACUHO will be elected by the Voting members. The Treasurer and Website Administrator shall serve three year terms. The Past- President, President, and President- elect shall serve one year in each position, for a total of three years. The Secretary, Newsletter Editor and Products and Services Coordinator shall each serve two year terms. However, unless they formally resign or are removed from office, directors will remain in office until their successors are properly elected, designated or appointed. No officer may serve more than two full terms in any one office.

#### PROPOSED BY LAW CHANGE:

#### ARTICLE V. OFFICERS

Section 2. Election and Term of Office. The officers of NWACUHO will be elected by the Voting members. The Treasurer and Website Administrator shall serve three year terms. The Past- President, President, and President- elect shall serve one year in each position, for a total of three years. The Secretary, Newsletter Editor and Products and Services Coordinator shall each serve two year terms. State and Provincial Representatives are appointed for two year terms by the Board of Directors and include representatives for Alaska, Alberta, British Columbia, Oregon, and Washington. However, unless they formally resign or are removed from office,

directors will remain in office until their successors are properly elected, designated or appointed. No officer may serve more than two full terms in any one office.

#### ADDITION TO BYLAWS:

#### ARTICLE V. OFFICERS

Section 13. <u>State and Provincial Representatives</u>: The State and Provincial Representatives shall:

- A) Represent the voice of their respective state or province at meetings of the association.
- B) Correspond with member institutions regarding matters of the Association (including deadlines, newsletter articles, scholarships, awards, and other issues within the Association).
- C) Serve as members of the programming committee
- D) Serve on committees assigned by the Board of Directors








The Collegiate Readership Program, managed by USA TODAY, provides students with access to a daily assortment of newspapers on campus.
